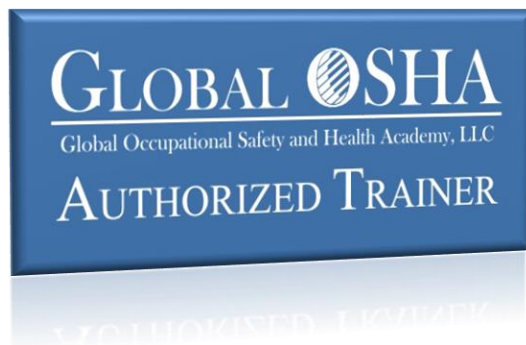


Become a Global OSHA Authorized Trainer

This course provides instruction for qualified safety professionals to become Global OSHA Authorized Trainers for construction safety. This enables the trainers to conduct introductory and intermediate level construction worker safety classes worldwide through the Global Outreach Training Program. Trainers may issue Global OSHA course completion wallet cards with embedded digital badges for their students.

Course topics include: Safety and Health Programs; Design, Delivery, and Evaluation; Working at Heights; Ladder Safety; Scaffolds; Cranes; Excavation & Trenching; Caught-in and Between Hazards; Tool Safety; Struck-By Hazards; Electrical Hazards; Construction Health Hazards; GHS, and Personal Protective Equipment.

Charles Shields - Executive Director, Global OSHA
